## CAMP MATTATUCK – J.N. WEBSTER SCOUT RESERVATION

### Scouts, BSA Weeklong Resident Camp

#### Camp Fees:

Troop SAVE-A-SPOT Campsite Deposit Fee	\$100	One-time fee per Unit to SAVE-A-SPOT
Early Bird Fee <i>Before May 1</i>	\$585*	If the balance is paid in full by May 1, 2026,  * Troops who deposited a Unit Campsite SAVE-A-SPOT before September 15, 2025, will be assessed \$575 a Scout per the incentive program.
Regular Camp Fee	\$599	Paid after May 1, 2026
Webelos / AOL Crossovers	\$585	These Scouts are always afforded the lowest possible camp fee rate.
New Scout Fee	\$585	For Scouts who join the troop as new Scouts between May and the beginning of the troop's week at camp.
National Youth Leadership Training	\$450	
Councilor in Training	\$225	One-time fee, May be selected to return at no additional charge.

#### Discounts:

Encore or 2 <sup>nd</sup> Week Camper Fee	\$430	The registration process will require identifying the Scout's other camp/week. To qualify, a scout must have <u>already spent a week</u> in a <b>BSA Scout Weeklong Camp</b> (Any Council), <b>Philmont</b> , or <b>National BSA High Adventure Base</b> , and the \$155 discount applies to a second week at one of the CRC's camps, <u>AFTER</u> the other program/camp. Programs must be after June 1, 2026.
Sibling Discount <i>(Per Child)</i>	\$25	A \$25 discount will be given to help those families with siblings attending Resident Camp. <u>The \$50 discount will be applied to the second Scout in BlackPug.</u>

#### Adult Leader Fees:


Two Adult Leaders	FREE	Two adults are required for minimum supervision per Youth Protection Guidelines. Additional <b>FREE</b> Leaders per the chart. Names of leaders are not required until May.
Additional Unit Leaders (Week)	\$180	Leader Fee (by the Week)
Additional Unit Leaders (Day)	\$35	Leader Fee (By the Day)

### Camperships:

The Connecticut Rivers Council will continue to award camperships to assist Scouts who need funds to attend camp and might not otherwise be able to do so. The annual campership fund is limited and fluctuates from year to year. Like Webelos crossovers and new Scouts, campership Scouts will also be afforded the lowest possible rate to attend camp. **Camperships should be submitted for consideration by April 1, 2026.**

### Refund Policy:

The Connecticut Rivers Council must commit financial resources to purchase equipment, hire staff, and otherwise prepare to provide high-quality programs in our camps well in advance of the camps opening for the summer. Participants, therefore, must be prepared to make a financial commitment to attend. Refund requests made before June 15th will be reimbursed the fee minus the cancellation fee of \$100. Requests after June 15th will be refunded the fee minus the cancellation fee of \$150. In the event of illness, we will process a refund if you are unable to attend camp. If a camp attendee presents signs of illness while at camp or misbehaves, we reserve the right to send them home without a refund.
